a. Total Gross Exposure is an estimate of a portfolio's exposure to all market activity (up or down markets). By finding the absolute value of our long and short exposure, one finds that 100.1% of MQR's capital is exposed to market fluctuations.

b. Total net exposure is an estimate of a portfolio's exposure to directional moves in the market. So while 100.1% of the portfolio is expected to move with market movements in either direction (total gross exposure) we would expect our portfolio to move 80.1% (net exposure) in the same direction as the market (ceteris paribus).

c. Total Gross Shorts (II) are not included in "Total Portfolio" as sale proceeds from the short sale are used to collateralize the position.
